#### Tip no. 1 - PRACTICE! PRACTICE!

Try to encourage your child to practise everyday for 20 – 30 minutes.

## **Tip no. 2 – SUPPORT OF THE PARENTS!**

To help ensure receiving a positive result on exam day, it is absolutely imperative that during the preparation of the exams that you the parent monitor the practice of your child. If there is something your child does not understand, please do not hesitate to contact the MOM office.

## **Tip no. 3 – NOTIFICATION OF DATE EXAM TO BE HELD!**

In regards to the date of the Exam your child will be notified in Term 4, on the Signature Chart. (The exam applies to students in the Gr: 2 - 6 program ONLY, Prep & Gr: 1's – no exams).

## **Important issues to discuss with your child:**

### **STUDENTS LESSON TIME:**

Please make sure your child is aware of his/her lesson time and that they are arriving on time. If the teacher needs to run around between the classrooms looking for a student it can effectively cut into the lesson time and be extremely disruptive to others in the group. Mad On Music cannot be responsible for shorter lessons due to student tardiness. If students are unsure of their times they are to see their MOM Teacher immediately.

### **BOOKS DURING THE MAD ON MUSIC LESSON TIME:**

Mad On Music are finding that there are an increasing number of students forgetting to bring all their books to lessons, which affects the students progress. Mad On Music cannot effectively conduct lessons without all relevant books at each lesson.

### **CURRICULUM DAYS/ SPORTS DAYS/ SWIMMING TIMETABLES**

Please ensure to let Mad On Music know of Sports Days/Curriculum Days/Swimming etc. Mad on Music needs to be informed at **least one week prior from either the parents** or the school in order to give a makeup. Parents, **please help** by letting the Mad on Music office know of this as early as you can.

## **DISCONTINUING**

MOM goes to great lengths to give the best possible tuition and ensures we hire quality teaching staff to enrich your child's learning. To do this we must ensure the teachers a set timetable for the term. Like everyone, teachers need to budget and financially plan their term and they cannot do this if students discontinue after the cut off day. This makes for unhappy teachers, and good teachers leave to find positions elsewhere. Teachers need to be respected just as MOM respects your child's place in the program. Once the timetable has been set your position has been accounted for, and the teachers are paid in advance for the term according to the timetable. Therefore aiming to discontinue after the final cut off day below is not tenable.

If your child is discontinuing lessons, notification must be given **in writing** to the **MOM OFFICE (not the school office)** three (3) weeks before the start of the school term. If that is not received, your child will automatically be enrolled and payment will be expected by the due date. You **MUST** follow up your discontinuing letter by a phone call to make sure we have received your letter.

**ALL STUDENTS ARE AUTOMATICALLY RE-ENROLLED AND PAYMENT EXPECTED BY THE INVOICE DATE, UNLESS PROMPT WRITTEN NOTIFICATION OF DISCONTINUING HAS BEEN RECEIVED**
